Our services include warehousing and delivery of stock items as well as "Aldi Specials" & "Middle of Lidl." These services are supported by repacking and relabelling services as and when required.















Freight Forwarding & End to End Logistics Services





- With the Port of Liverpool literally on our doorstep, we provide wrap around Logistics services in the North West of England.
- Our services provide a "one stop shop" for suppliers to Aldi & Lidl



 We utilise customer container volumes to drive down unit costs by utilising merchant haulage and multimodal rail freight services



• We work with different approved European Logistics providers who bring in Full Trailer loads to our warehouse for groupage distribution to Aldi & Lidl Regional Distribution Centres.



Drop & Swap Container Services Ex Port of Liverpool

Our drop and swap system is designed to create efficiencies within the supply chain. It works by utilising resources and combining them with warehousing slots to maximise time usage.

The main advantages are:

- Collection from the Quayside made as soon as the container is cleared
- We manage the Customs Clearance
- Avoids Quay Rent
- Drops full container and trailer on the bay at customer premises
- Unit collects empty container and trailer from same location or at another customers premises
- Returns Container to Quayside before charges are due
- Avoids demurrage charges at point of delivery as trailer put on bay and traffic office advised when container is empty
- Collection and deliveries can be organised to suit times either a.m. or p.m.
- Potential to reload Containers with export loads
- Saves money and time through efficiencies





UK Bonded Warehouse Ex Port of Liverpool & BRC Warehousing Services

We do not operate our own Bond, but introduce our customers to companies that specialize in both wet and dry Bonds. Our customers deal directly with the Bond ensuring integrity of information.

Bonded Warehouse Location:

Port of Liverpool

BRC Approved Multi User Warehouse – Port of Liverpool

We utilize this facility to de-stuff containers and palletize goods within the Port of Liverpool. This helps avoid Quay Rent, demurrage costs etc. and helps ease supply chain strain during peak periods.

Rates are governed by product volumes per container and often small period of free storage can be agreed to allow our trailers to come in and collect pallets on a just in time basis









Supermarket Logistics Distribution Centre

Our Supermarket Logistics Services & Operations are based at our BRC certified warehouse in Warrington. Through collaboration and agreements, we use our international customer base to support Domestic importers and manufacturers to benefit from economies of scale.

We use all methods to offload Containers. We can handball loose cartons, use fork lift trucks for palletised cargo, or use our slip-sheet attachment to push and pull products and place on pallets prior to shrink wrapping.










Our Supermarket consolidation hub provides the full range of logistics services required in demanding markets. We provide stock transfers, order fulfilment, and part load services e.g. I-5 pallets upto full loads, with a fully integrated logistics and warehousing management system. Customers can log in to our password protected Portal to check stock balances at any time.


Supermarket Logistics Services

- Weekly invoicing with all pod's scanned electronically







Pallet Consolidation Services





- Packing shippers
















Road Freight

Our services

SCS Road Freight covers both domestic haulage and European road transport. Our Groupage & Full Load services provide both economic delivery for small pallet loads or dedicated trailers for express delivery of full loads. We utilise approved UK & European hauliers who go through an <u>Approved Supplier</u>



Our UK & European Express Logistics Service uses Sprinter, Luton Box & Drop side vans that carry up to 4 pallets circa 1100kg, usually collecting within six hours of an order being placed from within the UK. These vans provide a valuable resource when freight simply has to be there.
